## IMPORTANT TERMS OF OUR HOME EQUITY LINE OF CREDIT PLAN

This disclosure contains important information about our Home Equity Line of Credit Plan. You should read it carefully and keep a copy for your records.

AVAILABILITY OF TERMS: All of the terms described below are subject to change. If these terms change (other than the annual percentage rate) and you decide, as a result, not to enter into an agreement with us, you are entitled to a refund of any fees that you pay to us or anyone else in connection with your application.

SECURITY INTEREST: We will take a security interest in your home. You could lose your home if you do not meet the obligations in your agreement with us.

POSSIBLE ACTIONS: We can terminate your line, require you to pay us the entire outstanding balance in one payment, and charge you certain fees, if (1) you engage in fraud or material misrepresentation in connection with the plan; (2) you do not meet the repayment terms of this plan, or (3) your action or inaction adversely affects the collateral or our rights in the collateral.

We can refuse to make additional extensions of credit or reduce your credit limit if (1) any reasons mentioned above exist; (2) the value of the dwelling securing the line declines significantly below its appraised value for purposes of the line; (3) we reasonably believe that you will not be able to meet the repayment requirements due to a material change in your financial circumstances; (4) you are in default of a material obligation of the agreement; (5) government action prevents us from imposing the annual percentage rate provided for in the agreement; (6) the priority of our security interest is adversely affected by government action to the extent that the value of the security interest is less than 120 percent of the credit line; (7) a regulatory agency has notified us that continued advances would constitute an unsafe and unsound business practice, or (8) the maximum annual percentage rate is reached.

MINIMUM PAYMENT REQUIREMENTS: You can obtain credit advances for 5 years. This period is called the "draw period." At our option, we may renew or extend the draw period. The length of the repayment period will be 15 years. During the draw period your monthly payment will equal the finance charges (interest) that accrued on the outstanding balance during the preceding month. Your payment will include any amounts past due and any amount by which you have exceeded your credit limit, and all other charges. If the interest rate increases you will have to make a higher payment. At the beginning of the repayment period we will recalculate your payment. Your payment will be set to repay the balance at the current annual percentage rate over 15 years. Each time the annual percentage rate changes, we will adjust your payment to repay the balance within the time remaining to maturity. Your payment will include any amounts past due and any amount by which you have exceeded your credit limit and all other charges.

MINIMUM PAYMENT EXAMPLE: If you made only the minimum monthly payment and took no other credit advances it would take 20 years to pay
off a credit advance of $\$ 10,000$ at an ANNUAL PERCENTAGE RATE of $3.25 \%$. During that period, you would make 60 payments of $\$ 24.93$ to $\$ 27.60$, followed by 179 payments of $\$ 70.28$ and one (1) final payment of \$68.25.

FEES AND CHARGES: In order to open, use and maintain a line of credit plan, you must pay the following fees to us:

## Application Fee: $\quad \$ 250.00$ (Due at application)

Check Printing Charge: (Due when checks are ordered.) The fee for these checks will be the fee that the credit union is charged by the check vendor.

You must pay certain fees to third parties to open the plan. These fees generally total between $\$ 436.00$ and $\$ 1,500.00$. If you ask, we will provide you with an itemization of the fees you will have to pay third parties.

The Credit Union may pay third party fees on your behalf, but if you close your Home Equity Line of Credit Plan within 3 years of its opening date, you agree to reimburse those fees as disclosed on the Addendum in the Schedule of Closing Costs.

PROPERTY INSURANCE: You must carry insurance on the property that secures this plan. If the property is located in a Special Flood Hazard Area we will require you to obtain flood insurance if it is available.

REFUNDABILITY OF FEES: If you decide not to enter into this plan within three business days of receiving this disclosure and the home equity brochure, you are entitled to a refund of any fee you may have already paid.

TRANSACTION REQUIREMENTS: After you obtain the first advance, the minimum amount of each subsequent advance is $\$ 200.00$ if accessed by the checks issued to you for this purpose.

TAX DEDUCTIBILITY: You should consult a tax advisor regarding the deductibility of interest and charges for the plan.

VARIABLE RATE FEATURE: This plan has a variable rate feature and the annual percentage rate (corresponding to the periodic rate) and the minimum payment may change as a result. The annual percentage rate includes only interest and no other costs.

The annual percentage rate is based on the value of an index. The index is the Prime Rate published in the Money Rates column of the Wall Street Journal. When a range of rates has been published the highest rate will be used. We will use the most recent index value available to us as of the 25th day of the month preceding the date of any annual percentage rate change.

To determine the annual percentage rate that will apply to your account, we add a margin to the value of the Index. This margin will be determined using certain credit-worthiness criteria and the loan to value of the property
offered as security. If the rate is not already rounded we then round up to the next .25\%.
From time to time the initial annual percentage rate may be "discounted" it would not be based on the index and margin used for later rate adjustments. The initial rate will be in effect for 6 months. Ask us for the current index value, margin, discount and annual percentage rate. After you open a plan, rate information will be provided on periodic statements that we send you.

RATE CHANGES: The annual percentage rate can change on the first day of each month. The rate cannot increase or decrease more than 0.5 percentage points at each adjustment. The initial discount rate will not be taken into account in applying this periodic rate cap. The maximum ANNUAL PERCENTAGE RATE that can apply is 18.0\% or the maximum permitted by law, whichever is less. However, under no circumstances will your ANNUAL PERCENTAGE RATE go below 3.0\% at any time during the term of the plan.

MAXIMUM RATE AND PAYMENT EXAMPLES: If you had an outstanding balance of $\$ 10,000$ during the draw period, the minimum payment at the
maximum ANNUAL PERCENTAGE RATE of $18.0 \%$ would be $\$ 152.88$. This annual percentage rate could be reached at the time of the 30th payment of the draw period. If you had an outstanding balance of $\$ 10,000$ during the repayment period, the minimum payment at the maximum ANNUAL PERCENTAGE RATE of $18.0 \%$ would be $\$ 161.11$. This annual percentage rate could be reached at the time of the 30th payment of the repayment period.

HISTORICAL EXAMPLE: The following table shows how the annual percentage rate and the minimum payments for a single $\$ 10,000$ credit advance would have changed based on changes in the index over the past 15 years. The index values are from the last business day of July of each year.

While only one payment per year is shown, payments may have varied during each year. The table assumes that no additional credit advances were taken, that only the minimum payments were made, and that the rate remained constant during each year. It does not necessarily indicate how the index or your payments will change in the future.
