## Treasurer's Report

During 2022, Pyramid -

- Set records levels for deposit and loan balances.
- Added 1,905 new members and our overall membership increased to 17,335.
- Sold our Speedway building.
- Increased our financial strength by adding \$3.5 million to our capital reserves.

Assets decreased slightly from \$233,931,547 to \$233,069,931.

Loans increased from \$132,102,621 to \$144,610,815.

Net income was \$790,494.

Dividends for 2022 were distributed as follows:

- Regular Shares \$45,108
- IRA Shares \$52,074
- Certificates \$224,275
- Money Market \$258,117

Distribution of 2022 income was as follows:

- Dividends \$584,242

## President's Report

2022 was another year of impact for our members, our community, and our credit union. There were many challenges during 2021 that we have never experienced before, but I am happy to report that we continue to grow and find new ways to serve our members.

During the last year, we –

- Upgraded our online banking system for a better experience including allowing you to view your credit score and enable you to track it and see how it can be improved.
- In early January 2023, we began to offer Zelle money transfers to your friends and family
- We upgraded our online banking alerts.
- We began to convert all of our credit and debit cards to contactless technology enabling faster and more secure transactions when using your Pyramid credit or debit card
- We remain part of the largest no-surcharge ATM network (CO-OP and Allpoint) which provides members access to more than 85,000 ATMs around the country without a surcharge.
- We improved our online account opening experience.
- We continued to support many Tucson non-profits through our employee and overall credit union donations.
- We had our member appreciation day at the zoo in early November that was attended by almost 400 people.

We have had our Annual Meeting virtually the past few years and we are expanding it this year by offering an in-person/online meeting. We have taken those savings and offered more scholarships to our young members through the Munday Curd Scholarship program. In 2022, we offered 3-\$1,000 scholarships and in 2023, we are offering 5 more. We have now provided 75 scholarships since its inception.

One of the best compliments we can get is a referral. We ask you to continue to think of family members, co-workers and friends who might benefit from joining the Pyramid family and encourage them to become members, too. As part of our enhancements, Pyramid now offers online account opening, making it easier than ever for anyone who wants to join. If someone is looking for a new financial institution, I hope you will refer them to Pyramid FCU.

Finally, I would like to thank all of our volunteers and employees for their efforts this past year. I would also like to thank our members for their understanding as Covid-19 made it a challenging couple of years, but we continue to find better ways to serve our members.

We appreciate your loyalty and your confidence in Pyramid Federal Credit Union.
